Apple's iOS 7 General Overview

- Controlled ecosystem of hardware, software and “cloud” services
 - iPhone, iPad, iPod
 - App Store, iTunes, iBooks, iPhoto, iCloud
- Transferable skills between devices
- Greatest number of apps

Google's Android 4.4 (Kit Kat)

General OS Overview

- Largest market share
- Open source
- Many “flavors” of OS affects uniform accessibility performance across OS versions
- Tight integration with Google services
 - Gmail, Google+, Hangouts, Drive
- Often less expensive than iOS devices
- “Widgets” provide custom functionality and shortcuts to apps
- Manufacturers overlay their own “skin”

An Introduction to Hearing Aid Compatibility (HAC) Ratings

Hearing Aid Compatibility (HAC) Ratings

- Each phone has an “M” and/or “T” rating
 - “M” = Performance while on microphone mode
 - “T” = Performance while coupled to hearing aid’s Telecoil (T-coil)
 - Newer hearing aids and cochlear implants have T-coil switch
 - Eliminates some of the background noise
- Higher the rating = Higher the performance
- Try Before You Buy!

Made for iPhone Hearing Aids

- Top hearing aids manufacturers have designed hearing aids specifically for iPhone
- These hearing aids deliver:
 - power-efficiency
 - high-quality digital audio experience,
 - manage hearing aid from iPhone
- Models:
 - GN ReSound (model: Resound LiNX)
 - Beltone (model: Beltone First)

Apple - Hearing Aids Settings

- Settings available in iOS 7 to maximize performance between hearing aids and iPhone.
 - iPhone 4: Decreases transmission power
 - iPhone 5: Modifies acoustic settings to improve compatibility in “T” mode
- Bluetooth connectivity option

Steps to access Hearing Aids Settings:

1. Select Settings
2. Select General
3. Select Accessibility
4. Select Hearing Aids

 - High quality
 - Fast frame-rate
- Integrated with Contacts

Access Apple Facetime

Steps to access FaceTime:

1. FaceTime App
2. Select Contact
3. Select FaceTime menu item

Video Calling and Text Messaging (Integrated)

Android - Hangouts

- Allows one-on-one or group conversations
 - Supports text and video calling
 - Available on computers, Android and iOS devices
 - Integrated with your Google account
 - Share photos and locations

Access Video Calling using Hangouts

Steps to access Video Calling using Hangouts

1. Select Hangouts app
2. Access Contact List (top right corner)
3. Select from Contact List
4. Select Camera icon (top right corner)

iOS - Apple

Text Messaging

Apple - iMessages

- Texting app
- Unlimited free texts between iOS and Mac users
 - Photos, videos, locations
 - Synchs between all iOS devices you may own

Access Apple iMessages

Steps to send text message:

1. Messages App
2. Access Contact List (top right corner)
3. Select from Contact List
4. Select “Send” after message typed

Apple - Visual and Vibrating Alerts

- Vibrating or LED alerts to notifications
 - Email, texts, voice calls

Access Apple Vibrating on Ring

Steps to enable Vibrate on Ring:

1. Settings
2. Sounds
3. Turn on Vibrate on Ring

Access Apple LED Flashing for Alerts

Steps to enable and disable LED Flashing:

1. Settings
2. General
3. Accessibility
4. LED Flash for Alerts

Vibrating and Visual Alerts

Android - Vibrating & LED Alerts

- Vibrating or LED alerts to notifications
 - Email, Texts, Voice calls

Access Android LED Flash

Steps to enable LED Flash:

1. Settings
2. Display
3. Pulse notification light

Access Android Vibrate when Ringing

1st method to enable Vibrate on Ring:

1. Phone
2. Options (bottom right of screen)
3. Call settings
4. Vibrate when ringing

2nd method to enable Vibrate on Ring:

1. Settings
2. Sound
3. Vibrate when ringing

- Provides CC or subtitle support to:
 - movies, podcasts, TV shows
 - iTunes, YouTube, Netflix
 - Look for “CC” icon
- Many options to customize font:
 - size
 - style

Access Apple Subtitles & Captioning

Steps to access Subtitles & Captioning options

1. Settings
2. General
3. Accessibility
4. Subtitles & Captioning
5. Option to enable or disable feature, and select from various styles

- Provides CC or subtitle support to:
 - movies, podcasts, TV shows
 - Play store, YouTube, Netflix
 - Look for “CC” icon
- Many options to customize font:
 - size
 - style

Steps to access Subtitles & Captioning options

1. Settings
2. Accessibility
3. Captions
4. Options include Language, Text size, Caption style, Font family, Text color, and Edge type

- May need a TTY adapter to use with TTY machine

Access Apple TTY Settings

Steps to access TTY settings:

1. Settings
2. Phone
3. TTY

TTY Support

Android - TTY Support

- Teletype (TTY) machines are used by deaf and hard of hearing people to communicate by typing and reading text.
- May need a TTY adapter to use with TTY machine and audio jack on Android phone

Access Android TTY Settings

Steps to enable TTY settings:

1. Phone app
2. Options (bottom right)
3. Call Settings
4. TTY mode. Options include: TTY Off, TTY Full, TTY HCO, TTY VCO
